1. Welcome

The Chairman welcomed Calum Crichton as the new Junior Co-Ordinator and Phil Gibbs as the Acting Secretary to their first council meeting.

2. Apologies

3. Minutes of last meeting

It was proposed that paragraph 9 of the last minutes be changed to read:

9. RW is stepping down at the end of the season, and the Council Members are encouraged to seek a successor. FT has indicated that she will be stepping down at the same time, so will not be in a position to step up to Chairman.

The current Tex Solutions website is lacking care and maintenance and is not up to date. MR has had difficulties getting financial contacts for clubs, but this is now resolved.
